This begs the question as to why, when the pandemic was first declared, tens of millions of dollars were thrown into dozens of research projects to find a ‘New’ (patentable), expensive, and difficult to store and transport vaccine, with an untested safety record, and rushed to market.

So think for example of the most idiotic and unnecessary drug a man could ever be on, like statins, that cause (besides muscle weakness, memory loss, type 2 diabetes and heart attacks) **Erectile Dysfunction**, which might just lead to a man taking Viagra, which hikes up blood pressure leading to a BP med prescription, which might later lead to a heart arrhythmia leading to yet another drug, you get the picture.

All those four drugs may cause a stomach problem which will also need drugging, since the number one side effect of any drug in the world is always 'upset stomach' (read any label or insert).

We now know by the way, that there's a direct connection between the gut and the brain (via the vagus nerve), so now perhaps our guinea pig patient starts to feel a little down on life and is prescribed an antidepressant to get through the day, and a sleeping pill to get through the night.

No one tells our friend that his sleeping pill interferes with the quality of his sleep, and so his brain stops making ADH (anti-diuretic hormone), a hormone that should stop the bladder filling up during the night.

The above study shockingly reveals that between 1999 and 2018 they spent an outrageous **\$4.7 Billion** on political campaign contributions.

The JAMA report goes on to say, speaking specifically about vast chunks of money; ***"The industry spent \$414 million on contributions to candidates in presidential and congressional elections, national party committees, and outside spending groups.***

Of this amount, \$22 million went to presidential candidates and \$214 million went to congressional candidates. Of the 20 senators and 20 representatives who received the most contributions, 39 belonged to committees with jurisdiction over health-related legislative matters, 24 of them in senior positions"

So they clearly target individuals in senior positions within healthcare, which is obscene.

Later, the report states;

"In years in which key state referenda on reforms in drug pricing and regulation were being voted on, there were large spikes in contributions to groups that opposed or supported the reforms"

I love that bit, but why don't you read the report for yourself, or, in a nutshell this below sums things up beautifully.

"The \$4.7 billion spent by the pharmaceutical and health product industry on lobbying and the \$1.3 billion spent on campaign contributions from 1999 to 2018 was only about 0.1% of the estimated \$5.5 trillion (in 2018 dollars) spent

on prescription drugs in the US over the same period. As a percentage of their revenues, well-resourced drug industry groups had to spend relatively little in their efforts to influence political and legislative outcomes. In contrast, many organizations advocating for the interests of patients and consumers have more limited financial resources”

So buying off politicians is a drop in the ocean for big pharma.

Fact 3, Big Pharma are the biggest advertisers in all medical and scientific journals, which just happened to be the brainchild of the late media mogul, Robert Maxwell.

In 2017 The Guardian reported on these journals front company, ‘Elsevier’; *“With total global revenues of more than £19bn, it weighs in somewhere between the recording and the film industries in size, but it is far more profitable. In 2010, Elsevier’s scientific publishing arm reported profits of £724m on just over £2bn in revenue. It was a 36% margin – higher than Apple, Google, or Amazon posted that year”*

Another Media Mogul, Rupert Murdoch, owns; The New York Post, The Times of London, and The Wall Street Journal publisher Dow Jones & Company, Fox News, and 44% of the Sky Network in Australia. He also won’t have a bad word to say, or to be said about the big pharmaceutical giants in any of his media outlets, let alone to report on or promote a product that makes them no money during this crisis.

Fact 4, These pharmaceutical giants have been fined **billions of dollars, repeatedly, for criminal activity** over the years.

I’m sure everyone now knows that in December 2020, Pfizer became the first to receive an emergency use authorization from the FDA for a COVID-19 vaccine.

Emergency Use Authorization by the way, means they can knock any old shit together, super-fast, and be 100% free from liability if the shit hits the fan, as it did with the Swine Flu vaccine.

“In addition, Pfizer has agreed to pay \$1 billion to resolve allegations under the civil False Claims Act that the company illegally promoted four drugs – Bextra; Geodon, an anti-psychotic drug; Zyvox, an antibiotic; and Lyrica, an anti-epileptic drug”

I could go on all day, believe me, or do you think they changed their ethics since 2009?

Shouldn't we give them the benefit of the doubt, what with how every politician and doctor is patting them on the back right now, then just roll up our grandad's and old aunties sleeves for a shot of their latest toxic bollocks?

Nearly 10,000 women filed Prempro breast cancer lawsuits against Pfizer. By 2012, Pfizer settled most of the claims for more than \$1 billion.

A judge dismissed Lipitor lawsuits in 2017. Women who took the drug filed lawsuits after developing Type 2 diabetes. There is currently an appeal pending, plus a warning on the side effects insert now contains Type 2 diabetes as a possible side effect!
